

CHARTER

OF

BRITISH SPORTS CAR CLUB, LTD.

The undersigned natural persons, having capacity to contract and acting as the incorporators of a corporation under the Tennessee General Corporation Act, adopt the following charter for such corporation:

- 1. The name of the corporation is British Sports Car Club, Ltd.
- The duration of the corporation is perpetual.
- The principal office of the corporation is located in Shelby County,
 Tennessee, and its address is P. O. Box 38009, Germantown, Tennessee 38138.
 - 4. The corporation is not for profit.
- 5. The corporation is organized for pleasure, recreation, and other non-profitable purposes connected with the restoration, preservation, and use of British sports cars; together with such other activities relating to the use and enjoyment of British sports cars as may be appropriate under the laws of Tennessee and within the purposes described in Section 501(c)(7) of the Internal Revenue Code of 1954.
 - 6. This corporation shall have members.
- 7. No dividends shall be paid and no part of any net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private persons, except that the corporation may pay reasonable compensation for services rendered and make reasonable reimbursement for expenses incurred on behalf of the corporation together with appropriate payments and distributions in furtherance of the purposes set forth in Paragraph 5 hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities which are not permitted to be carried on by a corporation exempt from federal income taxes under Section 501(c)(7) of the Internal Revenue Code of 1954.

8. Upon dissolution of the corporation and after paying or making provision for payment of all the liabilities of the corporation, the assets of the \(\frac{15}{3} \) corporation shall be distributed in a manner agreeable to a two-thirds (2/3) majority vote of all members not inconsistent with the qualifications and requirements of Section 501(c)(7) of the Internal Revenue Code of 1954.
